The conditions within TDCJ are reprehensible. The grotesque neglect is shameful, criminal even. The "Ad Seg " program needs to be reevaluated. It is literally a torture chamber... I have a loved one who spent 4 years... locked in a box, never getting opportunity to see the light of day, enduring the Texas summer heat in a concrete building with metal doors with little holes for breathing...like an insect in a jar, inside a bread oven.., temperatures so high that soda cans explode... on top of all this, their food is reprehensible... they are being starved and fed meals a mongrel in the street would pass by...

I never thought in a million years something like this could happen in the USA.

And the drugs! How in the world is there a drug epidemic within the prison walls??? There is a huge problem that is not being addressed, overlooked, everyday.. m. Guards turn a blind eye. How can it be there are inmates in the grad program who are so strung out on drugs they are passed out in the halls and overlooked by the guards... the addicts need to be recognized and treated appropriately. They take away from the inmates who are trying to move forward. This is supposed to be a facility for reform.

Your Proposed Solution

There is no reason why the pigs get a/c and the humans don't. Whoever allows that is vile and despicable.

The inmates of TDCJ are people who made mistakes, if they are treated like animals, that's what they will become...and then they will eventually be released into society ... more depraved and embittered. That's not good for anyone.

I'm attaching a letter that was sent from an inmate... it is just a glimpse into the attitude within TDCJ . I know it shouldn't be a cakewalk but... this is unacceptable.
